## RESPONDING TO THE PANDEMIC

During late 2019 and early 2020, FEX was experiencing strong momentum on many fronts; however, by early March, COVID-19 had disrupted everything!


Our team responded to the challenge with a strong sense of purpose, pivoting and adapting to the new reality.



## Connecting the Peer Communities of Business Families and FEAs Online

Moving quickly to online platforms ensured our community stayed connected:

- In-person events for families transitioned into virtual meet-ups, which strengthened community engagement and birthed several specific-interest groups within our family communities.
- Many Personal Advisory Groups (P.A.Gs) continued to meet online while adjusting meeting duration and frequency to suit group members.
   P.A.G-specific education resources and workshops moved online.
- FEX's Community Ambassador program launch maintained momentum by moving orientation sessions and meetings online.
- FEA Community Calls were initiated to empower
   FEAs and help them connect with peers and learn from each others' experiences.
- FBN family gatherings were transitioned online featuring unique speakers and intimate conversations.



## **FEA Program Goes Virtual**

- Current in-class FEA Program cohorts transitioned successfully onto a virtual learning platform – in a matter of weeks – while maintaining exceptional quality and enhancing the FEA candidate experience.
- Exciting addition of a full virtual offering of the FEA Program scheduled for October, with strong interest and enrollment from near and far.





## **Pandemic-Related Knowledge and Resources**



A dedicated COVID-19 resource page was created with curated resources from partners and members.



Webinars were offered monthly, many of which touched on pandemic-related challenges.



We posted over 40 stories on social media highlighting the resilience of business families and how they pivoted during the pandemic.



The new FEX website, resource centre and FEA directory launched in June providing FEX members access to more than 1,400 exclusive resources.



Regularly hosted virtual meet-ups that allowed peers to connect and learn.



FEX joined the Canadian Business Resilience Network (CBRN), which brings together over 450 chambers of commerce and boards of trade, and over 100 of Canada's leading business and industry associations to focus on providing tools to mitigate the impact of the pandemic.

## Research and Voice - Family Enterprise Matters

## GOVERNANCE UPDATE

#### **New FEX Directors**

As promised at the 2019 AGM, the Board has moved forward on its commitment to open up the governance process. On June 1, the Governance & Nominating Committee issued a Call for Nominations for two new Directors to serve on the FEX Board for a

three-year term. The Committee was absolutely delighted to see a strong level of interest from the community with a total of 19 nominations received. As a result of the high quality of candidates coming forward, the Committee has decided to recommend an increase in the number of new Director candidates for the Board to six. At this time, the Committee is in the process of finalizing its recommendation on the slate of candidates for election for Board approval and inclusion in the official AGM Notice to be sent to members in August.

#### **New Board Committees**

The Board considered changes to its current committee structure in an effort to enhance governance processes and participation from the community. As a result, the Board has approved adding new standing committees to represent our key member communities: FEX families, FEA designates and FBN Canada families. These new committees will be Chaired by a Board Director and include a mix of Directors and non-Board members from the respective communities at large.





## **New Bylaws**

As part of its mandate, the Governance Committee recently undertook a review of the organization's bylaws in consultation with outside legal counsel. As a result, we have

identified several revisions or additions to the bylaws that will be put forward to the membership at the AGM. Details on the recommended revisions and the proposed member resolution will be included with the AGM Notice.





## FINANCIAL UPDATE

Our fiscal year ending December 31, 2019 showed significant improvement in results from operations compared to the previous year. The deficiency of revenue over expenses for 2019 was \$102,394 compared to a deficiency in 2018 of \$1,174,630. While still incurring a modest deficit, the overall improvement year over year demonstrates strong progress on the path to long term financial stability. Contributing to this reduction of approximately \$1 million was an increase in revenues of \$515,000 (22%) combined with a reduction in expenditures of \$529,000 (15%). The expenditure reduction results from a combination of initiatives including streamlining of operations, restructuring of activities in conjunction with our sister organization, Family Enterprise Xchange Foundation, and a decline in overall investment in organizational capability relative to prior years, reflecting the transition from start-up to ongoing operations.



## FOCUSING ON THE FUTURE

Of course, the near-term focus for FEX and our entire member community will be dominated by the continuing impact of the COVID-19 health and economic crisis, including navigating the road to recovery. However, as we look out to the medium to long term, the future of our family enterprise community is so much brighter. It is exciting to see the development efforts and the many investments of the past several years finally come together.



## **Our Connected Community**

Now more than ever, the benefit of belonging to a community of supportive peers is exceedingly valuable and reassuring. Our members rate being part of a connected community as a top priority for them. Within FEX, we have three distinct peer communities today:

- our FEX families, primarily small- and medium-sized business families from across Canada;
- our designated FEAs, multidisciplinary accredited family enterprise advisors who are committed to excellence in serving business family clients; and
- our FBN Canada families, multi-generational business families interested in connecting with their global peers.

True value of community lies in the connections made and relationships created and sustained. As we move forward into 2021, our focus will be on enhancing and improving our community experience, creating and enriching opportunities for community members to connect with each other, share their experiences, their challenges and support each other on their respective journeys. We will continue to connect through various programs and initiatives, including community meet-ups and calls, peer groups (P.A.Gs and FEA Groups), Community Ambassadors, and virtual events (in-person when safe again) such as Symposium, FEYA celebrations and Families Summit of Minds.

Our new and growing community for Next Gen deserves special mention. While still in the early stages, this group is very enthusiastic and engaged. In the coming year, we are very committed to supporting our Next Gen members in expanding and developing this new vibrant

community.



Interest in the FEA designation and program continues to grow as both families and advisors understand and embrace the unique skills and insights of FEA designates. Families need more than technical advice in dealing with the complexities and challenges of being a family in business together. Our focus in 2021 is to continue expanding the FEA program, increasing enrollment and growing the brand, while also updating and refreshing the quality content, including developing a full virtual offering for the future.

**Building our Content** and Learning Platform

While being part of a connected community is a top priority for you, we know that access to excellent

resources and best-in-class learning opportunities are also very important. Going forward, we will continue to invest in our content and learning platforms. The new FEX digital systems and tools are foundational to maintaining a robust content platform; however, we are also committed to curating the best resources available and keeping members up to date with information that is relevant to their current needs - topical, accessible and shareable. Leveraging the great resources of the newly merged Family Enterprise Foundation for the benefit of our member community will also be a key initiative in the coming year.

A stronger **Voice for Family Enterprise** 

The global crisis has caused the world to truly embrace the fact that family enterprise matters! It is family businesses from across Canada that will lead us to recovery and a return to prosperity, and at FEX we are committed to giving a voice to this community. In collaboration with Family Enterprise Foundation and other like-minded partners, we will conduct research on family business in Canada in support of giving voice to our community. And we will connect with policymakers and other stakeholders to share information on the importance of family enterprise to our economic and social well-being.
